NOTICE TO EXHIBITORS

ENTRY FEE: Obedience: \$35.00 (Includes \$3.00 AKC Event Service Fee and \$.50 AKC recording fee) , and \$25.00 for the second entry of the same dog.

CLOSING DATE FOR ENTRIES: Friday, April 11, 2025, at 12:00 P.M., after which time entries cannot be accepted, cancelled, altered, or substituted.

ACKNOWLEDGEMENT of entries will be made as soon as practical. After closing armband numbers together with a copy of the Judging Program will be emailed.

TELEPHONE AND UNSIGNED ENTRIES cannot be accepted. Entries not on official AKC entry forms and photocopies of entry forms without the Agreement and Instructions on the reverse side of the official AKC entry form are not acceptable. NO ENTRY shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

ENTRIES WILL NOT BE ACCEPTED WITHOUT FEES. Postdated and returned checks do not constitute a valid entry fee. MPWDC will add a collection fee to the amount of each returned check. THE TRIAL WILL BE OPEN from 7:30 A.M. TO 6 P.M. Dogs may arrive any time prior to their scheduled time of judging. All dogs must be on leash or crated while on the show site (both indoors and outdoors) except when being judged.

ONE ADMISSION will be allowed for each dog entered. Consult judging program for time of judging. JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. Dogs not required for further judging will be excused.

BITCHES IN SEASON: A refund, less recording fee, will be made for bitches coming into season between the closing date and the day of the trial, provided the request is made in writing and accompanied by a veterinarian's certificate.
